

# MINUTES FOR INTERNATIONAL SOCIETY FOR ANIMAL GENETICS GENERAL BUSINESS MEETING; 12 JULY 2019, LLEIDA, SPAIN.

Approximately 88 individuals in attendance.

James Kijas called meeting to order at 11:30 am in Lleida, Spain.

#### ISAG Fellows

James Kijas reviewed Fellow of Society award requirements and showed previous awardees. New Fellow of the Society inductee is Max Rothschild. A brief biography of Rothschild was read. Rothschild asked to come on stage and receive award. Rothschild gave brief speech thanking the society, his students, and his colleagues. Kijas noted Rothschild passionate participation on ISAG EC drove creation of the developing country bursary. Joan Lunney nominated Rothschild for award.

#### Editor in Chief report (Hans Lenstra)

#### Position and strengths of ISAG Society Journal

- Reviewers and Editors are part of a network
- High quality reviews
- Consistent policy
  - o 34% to peer review
- Public availability of published datasets
- Professional publishing
  - Free full color figures
  - Excellent technical editing and copy-editing
  - Author support for increasing visibility: supply email addresses of ten authors in your field, who will be sent your paper
- Impact factor moderate, but now recovered from 1.8 to 2.24
- Few submission on genomic selection
- Still no open access

#### Scope and target

- Reminder to Read the Authors' Guidelines
- Impact does not reflect the general quality of our papers, but a relatively low number of highly cited papers
- On the long term, better be well cited in Animal Genetics than not cited at all in Nature!

#### Data availability

- Allows reproducing data and meta-analysis: BIG DATA
- Dedicated databases:
  - Genbank nucleotide sequence, Ensemble Variation Archive, SRA, GEO, animalQTLdb, OSF, FigShare
- Exceptions after consulting Editor-in-Chief:
  - Consortium data
  - Data from breeding company: restricted access
- Accession codes to be provided during submission
- How do other journals handle this?
  - Mandatory data availability often not enforced

#### Near future: cOAlition S/Plan S: enforcing Open Access?

- So far subscription more profitable -> funding for bursaries
- No open access -> lowers impact factor
- No open access -> inhibits scientific communication

- Funders already forbid journals without OA and also to journals with optional OA as Animal Genetics
- Countries may stop paying subscriptions
- Editors and Editorial Board of Animal Genetics are now in favor of Open Access
- Combining our quality with OA may be an opportunity

#### Secretary's report (Sofia Mikko)

Activities over the last year have included IFAG Board Meetings, discussions and survey on "Future of ISAG", conference preparations, and TPS access to AGE. Survey results of "Future of ISAG" is available on ISAG website and EC will continue to work towards suggestions.

#### Conferences

The EC decided to propose Cape Town, South Africa to arrange the ISAG conference in 2021. Clare Gill has worked with the LOC to prepare the preliminary budget for conference. Members were asked to submit expressions of interest to organize ISAG2023. Five are interested.

#### GDPR

During the year the EC implemented a privacy statement according to the EU General Data Protection Regulation 2016/679. (GDPR). Other processors in this involved are Wiley & sons, Oxford, UK, the publisher of the peer reviewed scientific journal *Animal Genetics*, as well as Schuiteman Accountants, Veenendaal, The Netherlands who prepares the society and foundation annual financial reports. Hein van Haeringen assisted in this work.

#### Constitution

The ISAG and IFAG constitutions were updated by Sofia Mikko, Ingrid Olsaker, and Hein van Haeringen. There were numerous issues with translations and adjustments to the Dutch law. This has now been finalized and the constitutions are posted on the ISAG web site.

#### Editorial businesses

Tad Sonstegard has stepped down as Associate Editor and Yuri Tani Utsunomiya has started.

A publisher's meeting was held in Oxford, June 4, 2019. Attendees were: IFAG Board (Christian Looft and Sofia Mikko, editor Hans Lenstra and representatives from Wiley (Rosie Trice and Adam Wheeler).



Membership currently consists of 10 honorary, 174 institutional, 473 regular, and 1 staff.

#### Comparison tests (CT) 2018-2019

The ISAG Standing Committees offered comparison tests for the period of 2018 to 2019. Online application forms for each test was available on the <u>ISAG website</u>, and the deadline for applications was July 15, 2018. To participate in comparison tests, laboratories need to be paid Institutional members of ISAG and must maintain that membership for both years of the comparison test process (2018 AND 2019). Despite this, a few labs had not yet payed their membership dues by the deadline. Submission of applications after the deadline was not an option, but anyway FASS had to wait for some laboratories to process their due payment, and subsequently allow them to submit their applications.

There is an ongoing discussion on how to make the comparison test more efficient when many laboratories. The IFAG board has asked the chairs for suggestions on how to run the Comparison tests in an efficient and cost effective way. For the 2018-2019 CT, ISAG organized the shipping of samples using FedEx as the courier.

The deadline to request a second shipment of samples was December 15. Laboratories requesting additional samples was assessed an extra processing fee per set of additional samples. Shipment of these samples was planned to be completed no later than January 5, 2019.

ISAG administrative office (<u>ISAG@assochq.org</u>) helped out with technical problems related to the application forms. For technical questions on the tests, the contact was the chair in each respective committee chair. SNP for dog and cat are trials only as they determine the panels to include. Horse SNP was done by Veterinary Genetics Laboratory, UC Davis and not overseen by ISAG.

- Comparison tests for sheep and goats will be handled by the *Applied genetics of other species of economical interest* committee and the chair of that committee has agreed.
- The committee requested the name of the former *Applied genetics in sheep and goats* committee be changed to *Small ruminant genetics and genomics*. Also suggested that the *Ruminant genetics and genomics* committee be changed to *Cattle genetics and genomic*.

Motion from committee to change name of applied genetics in sheep and goats committee to small ruminant genetics and genomics. Motion seconded by Tosso Leeb. All in favor, none apposed. Motion passed.

Motion to rename Ruminant genetics and genomics to cattle genetics and genomics. Comment from the floor that it makes the committee too restrictive. Motion does not receive a second.

Kijas calls for question on secretary's report and there were none.

## Treasurer's report (Chrisitan Looft)

Christian Looft called to podium to provide financial report. Hein van Haeringen retired in March 2018 and Anke Foerester replaced him as ISAG Financial Administrator.

## ISAG portfolio performance:





Christian notes sharp loss due to market performance in 2018. Looft had moved portfolio to a more conservative so larger loss was mitigated. Average percentage is 3.8% per year.

Motion by Ernie Bailey that the Society is granting discharge to the Treasurer and Financial Administrator. Motion seconded by Max Rothschild. All in favor, none apposed. Motion passed.

Due to issues with Dublin meeting an MOU was drafted for Lleida and adopted to ensure risk and profit sharing will be 50/50.

Questions solicited in relation to the financial report but none received.

#### **Election results**

Election results were announced. Notes that each EC member can serve two four-year terms. In the transition of conference years from even number to odd number years, the terms were four plus three, or three plus four years. Overview of outgoing members was included on ballot but missing in error on the slides for the GBM.

#### Future ISAG conferences

This is not a binding vote but very important in assisting the EC in making a final decision. Following the conference the EC will reach out to each who submitted an expression of interest to gather additional details.

- Delegates from Sydney, Australia the stage to present. (16 hands raised)

Presentations concluded and Kijas noted that ISAG is lucky to have such a wealth of conference choices.
